9.1 FPL 2022/333 Gof Du, Penrhosfeilw, Holyhead.

Full application for demolition of existing dwelling and the erection of a replacement dwelling, together with associated works - the proposed development was considered to be out of character with the area and would likely impact and detract from AONB. The site was also understood to be outside the LDP. The increase in size will be detrimental to the wildlife, birds and the natural fauna in this sensitive area. Request that a condition prohibiting the use as holiday accommodation be included if the application was agreed.

9.2 FPL/2023/25 at Fferm Tan y Graig Farm, Lon Isallt, Trearddur Bay

Full application for the erection of an agricultural shed together with the installation of a new silage effluent tank on land – concerns about the size of the structure in the AONB.
