#### 7. **RECREATION AREA**

The annual inspection was due on 28.7.2025 and it was hoped that Holyhead Town Council would have completed the repairs to the swings before that. It was agreed to request quotations for resurfacing under the toddler play equipment so that this work could commence as soon as the numbers of summer visitors had diminished.

#### 8. VILLAGE HALL

There was some concern about the voting procedures at the Village Hall AGM on 19<sup>th</sup> June 2025. The AGM was followed by two Committee meetings the first immediately after the AGM the other on 8th July 2025 where further voting took place and new officers and Trustees were selected. It was clear that it was intended to make changes to the village hall constitution and as the Community Council was the Custodian Trustee, concerns were raised regarding certain aspects of the proposed changes. The original charity trustees carried personal legal and financial responsibilities, some of which protect the interests of the Community Council. Consequently, the Council did not wish to see the current trustees removed nor administration responsibilities changed until legal advice was received and the legal / liability issues resolved.

The Council would seek legal advice on the matters raised.

- 11.3 Cllr. Dafydd Rhys Thomas:- Had seen various suggestions for additional parking areas in the village but unfortunately there was no owners' permissions to use these sites. In the meantime the traffic wardens were in regular attendance and a great deal lot of parking tickets had been issued.
